**PART 1 -- ACCEPTANCE OF RESPONSIBILITY AND CONDITIONS OF LICENSE**

- (1) I shall never operate any vehicle, vessel, or aircraft while under the influence of marijuana.
  - (2) I shall never distribute marijuana to any person in exchange for anything of value.
  - (3) I shall never distribute marijuana to any person under the age of 21 years who is not a member of my family, or except for medical purposes authorized by the person's physician.
  - (4) I shall never distribute any marijuana that has been adulterated.
  - (5) I shall never commit any crime while under influence of marijuana.
  - (6) I shall never cultivate marijuana in any manner that is harmful to the environment.
  - (7) I shall never smoke marijuana in any way that exposes any person to marijuana smoke without obtaining their implied or explicit consent.
  - (8) I shall comply with the regulations of the Treasury Secretary for marijuana licensees.
- Upon the issuance to me of a United States marijuana license, I PROMISE TO COMPLY WITH THESE CONDITIONS. I UNDERSTAND THAT IF I FAIL TO COMPLY WITH THESE CONDITIONS I MAY BE SUBJECT TO CRIMINAL AND CIVIL PENALTIES.

**PART 2 -- STATEMENT OF QUALIFICATIONS**
